FISHING CHARTER / HUNTING LIABILITY WAIVER, RELEASE, AND ASSUMPTION OF RISK AGREEMENT

This Agreement is entered into by and between the undersigned Participant ("Participant") and GXS&O. LLC, doing business as GXS&O. LLC ("Company").

1. Acknowledgment of Activities

Participant acknowledges that GXS&O. LLC provides guided and unguided **hunting, fishing, boating, and outdoor recreational activities**, including but not limited to:

- Firearm and archery hunting
- Fishing charters and boating activities
- Use of vehicles, ATVs, boats, docks, blinds, and equipment
- Exposure to wildlife, weather, terrain, and natural hazards

Participant understands these activities involve **inherent risks**, including serious injury, permanent disability, drowning, property damage, or death.

2. Assumption of Risk

Participant **voluntarily assumes all risks**, known and unknown, foreseeable and unforeseeable, associated with participation in any activity provided by GXS&O. LLC, including risks arising from:

- Firearms, ammunition, and hunting equipment
- Boats, water conditions, and maritime hazards
- Slips, falls, uneven terrain, and environmental conditions
- Actions of other participants, guides, or third parties

3. Release and Waiver of Liability

Participant hereby **releases, waives, and discharges** GXS&O. LLC, its owners, members, officers, employees, contractors, guides, captains, and agents from **any and all claims**, demands, actions, or causes of action arising out of or related to:

- Personal injury or death
- Property damage or loss
- Negligence of GXS&O. LLC (to the fullest extent permitted by law)

4. Indemnification

Participant agrees to **indemnify and hold harmless** GXS&O. LLC from any claims, liabilities, damages, costs, or expenses (including attorney's fees) arising from Participant's actions or participation.

5. Medical Responsibility

This Agreement shall be governed by the laws of the **State in which the activity occurs**.

10. Severability

If any portion of this Agreement is found invalid, the remaining provisions shall remain in full force and effect.
